Feature 1: Understanding Non-Kinetic Operations and Non-Kinetic Capabilities for Irregular Warfare By AVM G. A. Bello, Defence Headquarters

AVM Bello offers an in-depth exploration of non-kinetic capabilities—ranging from psychological operations and cyber influence to civil-military engagement—as indispensable tools for modern irregular warfare. He emphasizes that success in such environments requires influencing adversary perceptions, fostering legitimacy among local populations, and integrating strategic communications with kinetic actions.

His paper calls for institutional reforms that prioritize intelligence, influence, and inter-agency cooperation, ensuring that the Nigerian Armed Forces operate with both moral authority and operational adaptability.

Feature 2: The Use of Soft Power and Technology in Policing and Crime Prevention


The paper concludes that technological sovereignty and digital literacy are critical to safeguarding Nigeria's non-kinetic posture in the information domain.

Drawing from direct operational experience, General Alabi-Isama revisits how the 3 Marine Commando Division integrated humanitarian relief. operations, psychological and civil engagement into its campaigns. His analysis demonstrates that wars are not only won on battlefields but through disciplined compassion and leadership. He draws parallels between those lessons today's asymmetric and security challenges-insurgency, banditry, cybercrime-urging modern commanders to balance might with morality.
